As the subject of an employment background check, your rights include:

- to be informed that Stages Theatre Company will request this check for becoming or continuing as an employee or volunteer, and to determine whether you have been convicted of any of the above specific crimes, and
- to be informed of the BCA's response and obtain a copy of the report from Stages Theatre Company, and
- to obtain from the BCA any record that forms the basis for the report, and
- to challenge the accuracy and completeness of any information contained in the report, and
- to be informed whether Stages Theatre Company has denied your application because of the BCA's response, and
- not to be required directly or indirectly to pay the cost of the background check.
